CALL FOR PAPERS

Held annually, which started in 2013, the International Conference in Accounting & Management Education, Research, and Practice (ICAMERP) is coming once again. The conference aims to establish interaction and collaboration between higher education institutions with the aim to learn with and from each other.

With this, the organizers are calling on prospective presenters to submit papers and posters that offer novel contribution in empirical, methodological or theoretical aspects. Papers shall be along the following four tracks:

- 1) Accountancy and Management;
- 2) Economics and Finance;
- 3) Information Technology and E-Commerce; and
- 4) Accounting/Economics/Management/Business Education.

Presentations should be in English. Abstract and paper submissions shall be sent electronically to icamerp.ucbcf@gmail.com. All abstracts will be published in a hard copy and online proceedings book. Selected full papers that are assessed to be of high quality and high impact are given priority to be part of the Journal on Accounting & Management Education, Research, and Practice (JAMERP) published through online and hard copy form.

Guidelines for Abstract Submission

Research articles that present empirical, methodological, theoretical, and practical approaches to issues in the fields of Accountancy and Management, Economics and Finance, and Information Technology and E-Commerce in the perspectives of Education, Research, and Practice are accepted. Studies that make use of qualitative, quantitative, or combination of methods are welcome. The conference also recognizes multidisciplinary approaches on the fields.

Research abstracts should be original, unpublished, and not under consideration in any journal publications. All submissions shall be in soft copy (word format at 8.5" x 11" size paper) and should not be more than 300 words.

The abstract submission should include:

- Title of the research; Name(s) of author(s); Institutional affiliation; Contact information: office phone, mobile phone, email address

ABSTRACT (in one-paragraph should include)

- Background of the study
- Problems/Objectives
- Scope of the work
- Methods used
- Salient results
- Implications of the main results or main conclusions
- Main recommendations

All papers submitted undergo blind refereeing process. The ICAMERP Steering Committee makes the final decision on the acceptability of submissions based on the review and evaluation in compliance to the instructions of the guidelines and format.
